INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims primarily for capital growth over the medium to long term by investing substantially in a selection of exchange-listed equities. Investments in bank deposits and other short-term fixed income instruments may be kept for liquidity and portfolio rebalancing purposes. The Fund's benchmark is the Philippine Stock Exchange Composite Index (PSEi).

CLIENT SUITABILITY




Fund's NAVPU vs Benchmark & Risk-Free Rate

OUTLOOK AND STRATEGY

After three consecutive months of positive monthly returns, the market succumbed to profit taking. There was also a notable decline in net foreign inflows amounting to only \$21M versus last September's value of \$346M. The PSEi shed 1.78% m/m to end at 7,142.96 in October. Early in the month, investors were in an upbeat mood on expectation of a more easing cycle ahead for both the US Fed and the BSP. The BSP cut the policy rate by 25 basis points to 6.0% for the second time as inflation hit sub 2% in September. However, the market lost steam on uncertainty over the US election. The market saw a more pronounced sell off nearing election day. The peso was also quick to react and weakened to Php58.10 to the US dollar, down 3.69% m/m from September level of Php56.03. Foreign outflows were evidently larger which knocked the PSEi back to the 7,100 level.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in exchange-listed equities and fixed income securities, deposits in the Trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP and tradable securities issued by any supranational entity. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.
