**INVESTMENT OBJECTIVE AND STRATEGY**

The Fund aims to achieve long-term capital appreciation by investing in a diversified portfolio of attractively priced exchange-listed stocks with sustainable dividend yields. The Fund's benchmark is the Philippine Stock Exchange Composite Index (PSEi).

**CLIENT SUITABILITY**

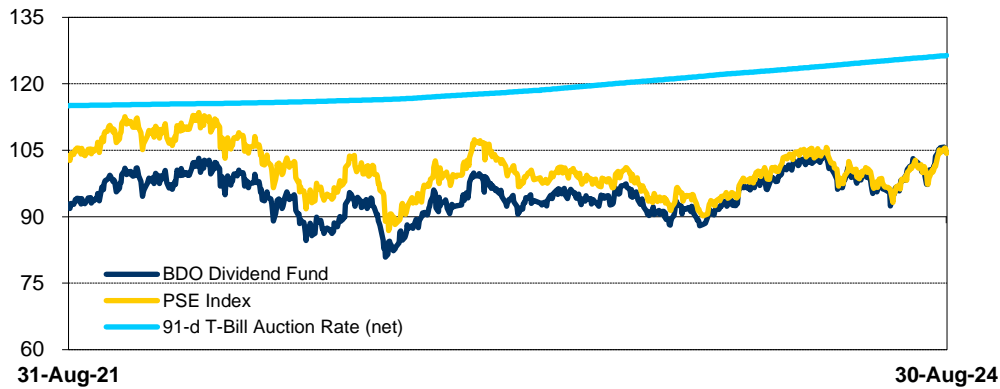

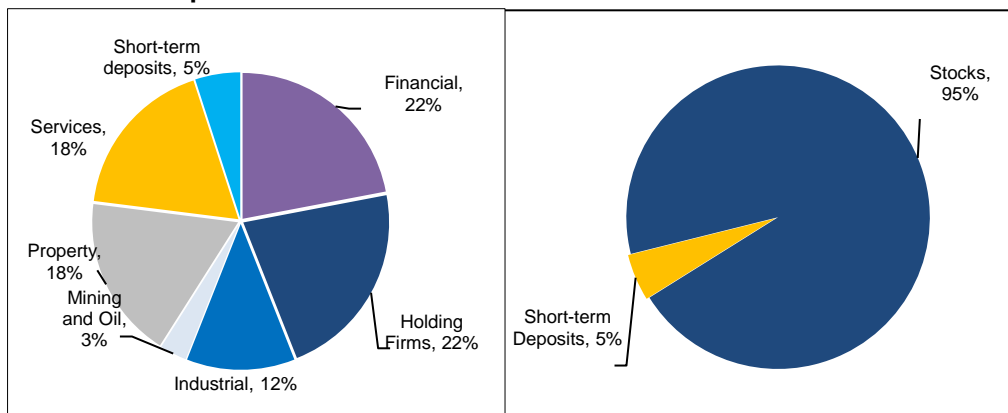

### OUTLOOK AND STRATEGY

Once again, the market rallied for the second month in a row. The PSEi gained 4.21% for the month of August to close at 6,897.54. Investors cheered over the much-anticipated BSP decision to cut the policy rate by 25 basis points to 6.25%. Moreover, sentiment got a lift on the expectation of a rate cut by the US Fed, with investors looking at a rate cut between 25-bps to 50-bps this September. Such optimism brought the Index to as high as 7,000, a level that was last seen in early April of this year. Value turn-over for the month improved to \$107M from July's level of \$86M as foreign investors were net buyers of the market. Notable market events in August were the release of the GDP print in 2Q24 where it expanded a year-on-year growth of 6.3% from 5.8% in 1Q24. The month also saw the end of the 2Q24 earnings season where most companies reported earnings in line with market consensus. The August headline inflation came in at 3.3% after a temporary blip last July of 4.4%. The slower inflation was largely driven by the sharp deceleration of food inflation and transport.

### INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in exchange-listed equities and fixed income securities, deposits in the Trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP and tradable securities issued by any supranational entity. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.
