



OUTLOOK AND STRATEGY

The stock market closed the month sharply lower as the PSEi plunged 7.41% m/m to end November at 6,613.85. Stock markets across Asia saw heavy selling pressure after a Trump victory. Market sentiment quickly turned negative as investors weigh the impact of the Trump trade policies across Asian markets. The PSEi was among the markets that were heavily sold down with net foreign outflows amounting to \$349M in November alone. Trump 2.0 is seen to make the US dollar stronger against Asian currencies as such, the month saw the Peso depreciating to Php59 versus the US dollar. On the flip side, Wall Street posted record highs as U.S. stocks are seen to benefit the most from Trump's "America first" policies. Meanwhile, the unimpressive data for GDP and CPI further pushed investors to the side line. Inflation in November stood at 2.50% following a slight uptick in non-rice components while 3Q24 GDP slowed to 5.20% versus consensus estimate of 5.70% and 6.40% previously.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS
