INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to provide investors with a total return which reflects the return of the Philippine Stock Exchange Composite Index (PSEi) by investing in a diversified portfolio of stocks that so far as practicable consists of the component companies of the PSEi. The Fund's benchmark is the Philippine Stock Exchange Composite Index (PSEi).

CLIENT SUITABILITY

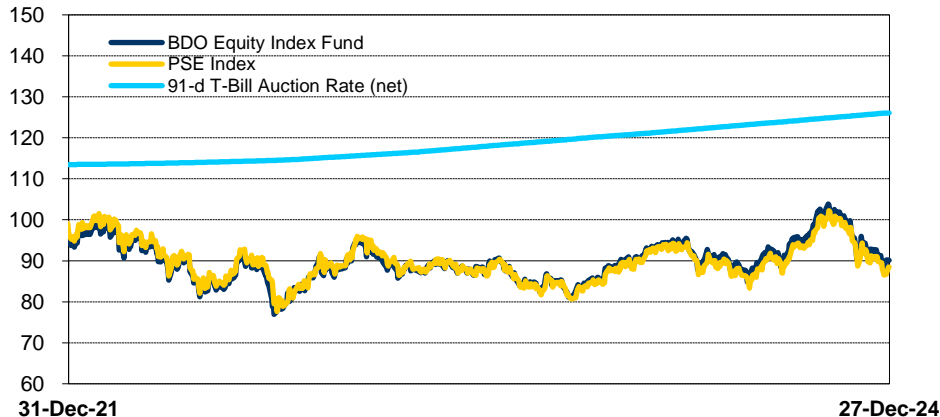

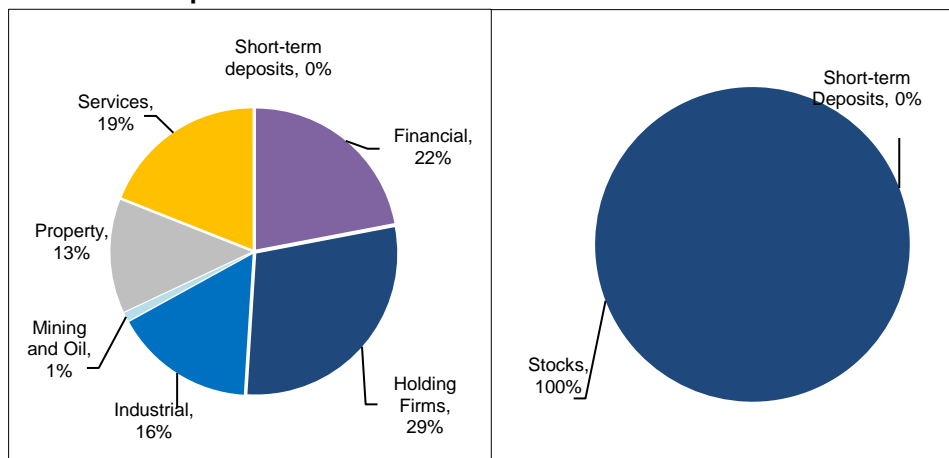
Fund’s NAVPU vs Benchmark & Risk-Free Rate

OTHER DISCLOSURES**OUTLOOK AND STRATEGY**

The PSEi continued to trend lower for the month of December albeit at a slower pace relative to the big drop in November. The month saw the stock market declined by 1.29% m/m while the Index's full year 2024 performance posted slightly higher at 1.22% y/y. After four straight years of negative returns for local equities, the PSEi finally closed the year in positive territory. The Index ended the year at 6,528.79 from 2023 level of 6,450.04. However, Trump's tariff threats remained an overhang as investors kept a close watch on how the trade policies will be carried out once President-elect Donald Trump takes office on January 20, 2024. On the local front, the weak peso continued to weigh heavily on investors' sentiment prompting foreign funds to partly unload their local equity positions. This translated to a net foreign outflow of US\$104M in December. Cyclical were sold down the most, Financials and Property sector fell more than 4% in a month on uncertainty over the rate outlook. The Federal Reserve has signaled for fewer rate cuts in 2025 and BSP could follow a similar trend.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in exchange-listed equities and fixed income securities, deposits in the Trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP and tradable securities issued by any supranational entity. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.
