INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve capital appreciation by investing in a diversified portfolio of peso denominated short to long-term fixed income securities, equity securities, and other allowable investments for UITFs. The allocation for equity securities shall not exceed 80% of the total portfolio of the Fund. The Fund's benchmark is 50% Philippine Stock Exchange Composite Index (PSEi) and 50% Markit iBoxx ALBI Philippines 1-5 (Domestic) Index (IBXXPH15).

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

- ♦The BDO Peso Multi-Asset Fund is primarily suitable for individual and corporate investors with balanced risk appetite and who are aware of the opportunity for high yields that portfolios with stock market investments may provide but are also knowledgeable of the possibility of capital losses that such investments may entail.
- ♦Participants/trustors are recommended to stay invested in the Fund for more than three (3) years.

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Interest Rate Risk. This is the possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.

All the Fund's investment outlets undergo evaluation in accordance with the Trustee's Investment Policy Manual. Regulatory exposure limits are monitored on a regular basis. The Fund may also use financial derivative instruments solely for the purpose of hedging risk exposures.

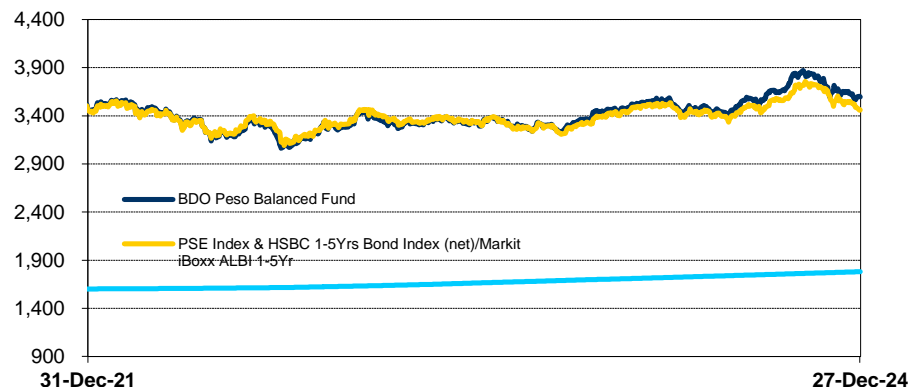

Fund's NAVPU vs Benchmark & Risk-Free Rate



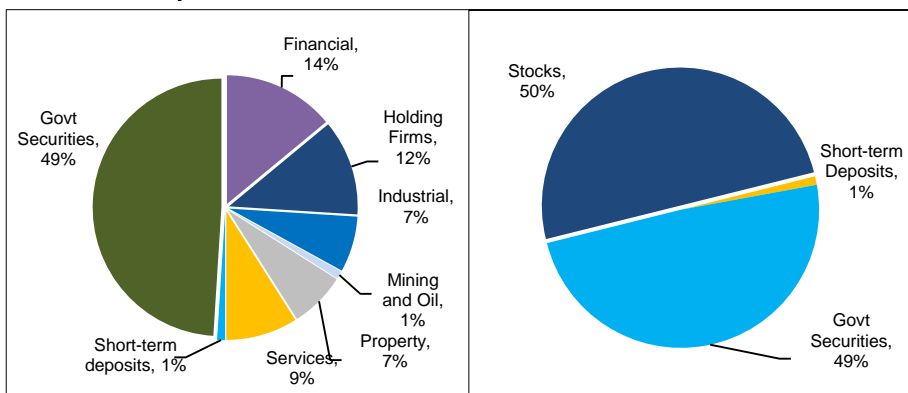

OUTLOOK AND STRATEGY

The PSEi continued to trend lower for the month of December albeit at a slower pace relative to the big drop in November. The month saw the stock market declined by 1.29% m/m while the Index's full year 2024 performance posted slightly higher at 1.22% y/y. After four straight years of negative returns for local equities, the PSEi finally closed the year in positive territory. The Index ended the year at 6,528.79 from 2023 level of 6,450.04. However, Trump's tariff threats remained an overhang as investors kept a close watch on how the trade policies will be carried out once President-elect Donald Trump takes office on January 20, 2024. On the local front, the weak peso continued to weigh heavily on investors' sentiment prompting foreign funds to partly unload their local equity positions. This translated to a net foreign outflow of US\$104M in December. Cyclical sectors were sold down the most, Financials and Property sector fell more than 4% in a month on uncertainty over the rate outlook. The Federal Reserve has signaled for fewer rate cuts in 2025 and BSP could follow a similar trend.

On the interest rate front, the BSP reduced its policy rate by another 25bps to 5.75% from 6.00% previously and rates on overnight deposits were also adjusted lower. On the other hand, the PH10-year bond yield moved higher, taking its cue from the uptrend in US treasuries as Trump's planned trade policies continue to put pressure on treasury yields. Meanwhile, December inflation was slightly higher at 2.90% versus last November print of 2.50%. The slight uptick was attributed to higher utilities and transport costs. However, most investors still see inflation rate to stay within the 2%-4% target range by the BSP.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in exchange-listed equities and fixed income securities, deposits in the trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP and tradable securities issued by any supranational entity. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.

OTHER DISCLOSURES

The Fund aims to provide absolute returns in excess of the return of the composite benchmark, 50% Philippine Stock Exchange index (PSEi) and 50% Markit iBoxx Philippines 1-5 (Domestic) Index (IBXXPH15). The stated benchmark is a measure that is used to compare the performance of the Fund. The benchmark also represents the Fund's portfolio as well as the movements in interest rates and stock market prices affecting the Fund's investments.

The Philippine Stock Exchange index (PSEi) measures the performance of the Philippine Stock Market. The PSEi is made up of the top 30 largest and most active listed companies, chosen to represent the general movement of the stock market.
